Train-the-Trainer

South Carolina Department of Education has contracted with Children's Trust to offer training in school districts across the state. Participants in this two-day training must complete two trainings after the initial train-the-trainer to become an official ACE Master Trainer. Participation in this training also connects you to a statewide network of over 200 other trainers to share resources and best practices.

Train-the-Trainer Learning Objectives

As a result of ACE Master Training, trainers will:

1. Be able to know and articulate clearly the ACEs research findings and their strengths, weaknesses, and implications.
2. Be able to know and articulate clearly basic information about how ACEs impact brain development and function as an adaptive response to environmental circumstances.
3. Be able to know and articulate clearly what community resilience is and how the development of community resilience can help reduce ACEs in children.
4. Be able to understand the impact that ACEs may have had on their lives and the lives of others.

Becoming a master trainer is the first step in a long-term relationship with Children's Trust. As the ACE Interface licensee for the state, we continually work on create and share resources that add to value of our trainers. We convene peer networking sessions to ensure continued learning and growth of our trainers.
